



ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southerly side of Creekside Road, near the City of Greenville, South Carolina, being known and designated as Lot No. 419 on plat entitled "Map 3, Section 2, Sugar Creek", recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7-X at Page 2, and having according to said plat, the following metes and bounds, to-wit:
