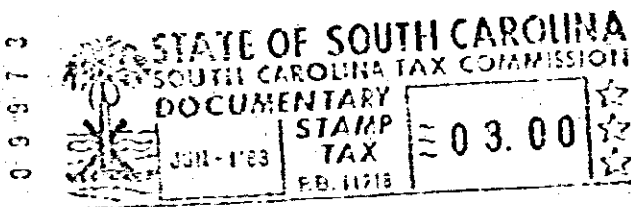

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot #4 on Plat of Property of P. L. Bruce, recorded in Plat Book MM at Page 123, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the north side of Pinedale Drive at joint corner of Lots #4 and #5 and running thence with the line of said lots, S. 19-27 E. 77.3 feet; thence N. 63-10 E. 114.5 feet; thence N. 37-31 W. 64.5 feet to a point on Pinedale Drive; thence with Pinedale Drive S. 70-33 W. 93.3 feet to the point of beginning.

DERIVATION: This being the same property conveyed to the Mortgagor herein by virtue of a deed from W. M. Batson recorded in the R.M.C. Office for Greenville County, S.C. in Deed Book 774 at Page 418 on May 31, 1965.
