THIS MORTGAGE is made this 12th day of October 1983 between the Mortgagor, Roger K. Nance & Janice A. Nance (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL BANK, FSB, a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-Five Thousand and 00/100 (\$55,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated October 12, 1983 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on November 1, 2013.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL THAT CERTAIN piece, parcel or lot of land, located in Greenville County, South Carolina, on Mitchell Road, being approximately 0.66 acres, as shown on a survey prepared by W. B. Huntley, III, Professional Land Surveyor, #8809, entitled "Property of Roger K. Nance and Janice A. Nance", dated June 10, 1983, and recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book 9-U, at Page 21, reference to which is craved for a more complete description of the metes and bounds thereof;

This property is conveyed subject to all restrictions, easements, rights of way or other encumbrances of record;
