- 1. That the loan balance at the time of this agreement is \$ 12,000.00 ; that the BANK is presently increasing the interest rate on the balance to 13.00 per cent per annum; that the BANK agrees to hereby amend the original terms of the aforementioned note and mortgage so as to extend the time for repayment for a period of 182 days, commencing on the 26th day of Sept. , 1983, so that the new maturity date of said note and mortgage shall be the 26th day of March , 1984.
- 2. That all terms and conditions as set forth in the original note and mortgage are continued in full force and effect, except as modified expressly by this agreement.
- 3. That this agreement shall bind jointly and severally the successors and assigns of the BANK and OBLIGOR(S), his heirs, successors and assigns.
