"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel and/or lot of land with all improvements thereon, situate lying and being in Greenville County, South Carolina, City of Mauldin, as shown on plat prepared by J.R. Montgomery, Jr., RLS, dated September 22, 1983 as recorded in the RMC Office for Greenville County, South Carolina in Plat Book 10B at Page 58, reference being craved hereto to said plat for exact metes and bounds.
