TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS,

we, Franklin D. Lewis and Mary C. Lewis

(hereinafter referred to as Mortgagor) is well and truly indebted unto Republic Federal Credit Union,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of ---Twelve Thousand and NO/100---

Dollars (\$ 12,000.00 ) due and payable

as set forth in promissory note of even date; entire balance of principal and interest,  
if not sooner paid, due ten years from date,

with interest thereon from date at the rate of --12-- per centum per annum, to be paid as set forth in said note,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, at the northwest intersection of Morrow Street and Hawkins Street, being shown and designated as LOT NO. THIRTY TWO (32) of Morrow Heights, as shown on plat prepared by H. S. Brockman, Surveyor, dated Sept., 1935, and recorded in the RMC Office for Greenville County in Plat Book I at pages 119 and 120, reference to said plat hereby pleaded for a more complete description as to metes and bounds, courses and distances, PROVIDED that a ten foot easement, over and under, the entire rear line of said lot is reserved unto the owners of Lot No. 31, their heirs, assigns and successors, and shall run with with land, said easement is for the maintenance and repair of existing sewer lines.

This conveyance is subject to all restrictions, easements, rights of way, roadways and zoning ordinances of record, on the recorded plats or on the premises.

This is that same property conveyed to Mortgagors by deed of D. Allen West, said deed to be recorded herewith.
