MORTGAGE

THIS MORTGAGE is made this 24th day of February, 1984, between the Mortgagor, William J. Prosser, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of \$9,159.84 Nine Thousand One Hundred Fifty Nine and 84/100 Dollars, which indebtedness is evidenced by Borrower's note dated February 24, 1984, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on February 28, 1992;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina.

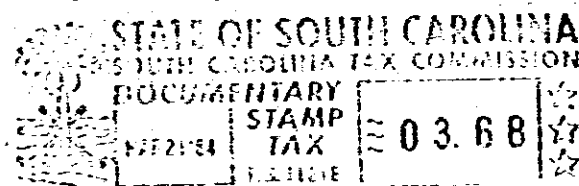
All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of Parker Road with Starsdale Circle, being shown and designated as Lot no. 1 on a plat of Starsdale Manor Subdivision, made by Dalton & Neves, Engineers, dated March, 1956, recorded in the RMC Office for Greenville County, SC, in Plat Book NN, page 9, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Starsdale Circle at the joint corners of lots nos. 1 and 2 and running thence along the common line of said lots, S. 21-25 E., 148.1 feet to a point; thence N. 80-45 E., 70.7 feet to an iron pin on the western side of Parker Road; thence with the western side of Parker Road, N. 4-58 E., 127.8 feet to a point; thence with the curve of the southwestern corner of the intersection of Parker Road with Starsdale Circle, the chord of which is N. 39-05 W., 30.2 feet to a point; thence along the southern side of Starsdale Circle S. 82-38 W., 80 feet to a point; thence continuing along said side of Starsdale Circle, S. 68-35 W., 40 feet to the point of beginning.

This being the same property conveyed to the mortgagor by deed of Charles E. Wright and Leola R. Wright and recorded in the RMC Office for Greenville County on July 11, 1977 in Deed Book 1060 at Page 206.

This is a second mortgage and is junior in lien to that mortgage executed by Fidelity Federal Savings and Loan Association and recorded in the RMC Office for Greenville County on July 11, 1977 in Deed Book 1403 at Page 601.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
