indebtedness outstanding at any one time secured hereby not to exceed \$ 9,279.39 charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees, has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the eastern side of Hiwassee Drive, near the City of Greenville, being shown as lot #19, on plat of Indian Hills, recorded in Plat Book QQ at Page 11, and described as follows:

BEGINNING at a stake on the eastern side of Hiwassee Drive, 1111.2 feet north from Sulphur Springs Road, at corner of lot 18 and running thence with the eastern side of said drive, N. 9-30 W. 90 feet to an iron pin at the corner of lot 20; thence with the line of said lot N. 80-30 E. 175 feet to an iron pin; thence S. 9-30 E. 90 feet to an iron pin at the corner of lot 18; thence with the line of said lot, S. 80-30 W. 175 feet to the point of beginning.
