"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, being known and designated as Lot No. 8 on a plat of FORD TOWN ESTATES, Section 1, recorded in Plat Book 6-H at Page 67, and having such metes and bounds as appear by reference to said plat.
