To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville.

All that certain piece, parcel, or lot of land, with the improvements thereon, situate, lying and being on the eastern side of Mayflower Avenue, in Pecan Terrace Subdivision, Greenville County, South Carolina, which is known and designated as Lot 14 of that Subdivision, as shown on a plat thereof recorded in the Office of the R.M.C. for said County, in Plats Book GG, Page 9, according to which Plat the property is described more particularly as follows: BEGINNING at an iron pin on the eastern side Mayflower Avenue, joint front corner of Lots 14 and 15, and running thence N. 17-33 E., 70 feet to an iron pin, thence S. 72-27 E., 150 feet to an iron pin; thence S 17-33 W., 70 feet to an iron pin; and thence N 72-27 W., 150 feet to an iron pin, the point of beginning.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

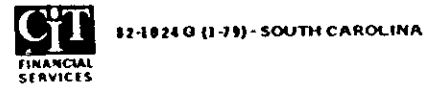
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
