**MORTGAGE**

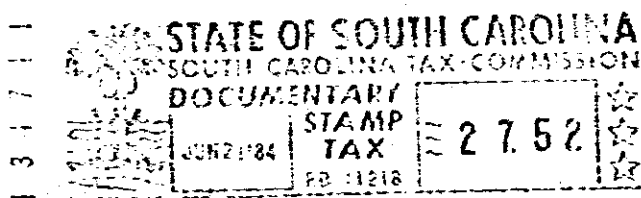
THIS MORTGAGE is made this 20th day of June 1984, between the Mortgagor, Steven Ray Elliott, Sr. and Judy L. Elliott (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL BANK, FSB a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty-Eight Thousand Eight Hundred and no/100ths (\$68,800.00) Dollars, which indebtedness is evidenced by Borrower's note dated June 20, 1984 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on July 1, 2014.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the western side of Galewood Drive and the northern side of Vera Circle, in Greenville County, South Carolina, being known and designated as Lot No. 11 on a plat of MORROW ESTATES, made by Jones Engineering Service, dated June, 1966, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book TTT at page 29, and according to a more recent plat by Carolina Surveying Company dated June 19, 1984, reference being made to said plat for the metes and bounds thereon, said plat being recorded in Plat Book 10-5 pg. 26.

This being the same as that conveyed to Steven Ray Elliott, Sr. and Judy L. Elliott by deed of Charles Tony Harrell and Diana Jean Harrell being dated and recorded concurrently herewith.



which has the address of Lot 11, Vera Circle, Greer, SC 29651 (City) (herein "Property Address"); (State and Zip Code)

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
