ALL that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, on the western side of Wood Circle and being known and designated as Lot No. 10 on a plat of "Revision of WOOD CIRCLE", recorded in the RMC Office for Greenville County in Plat Book WWW at Page 54, and having such courses and distances as will appear on said plat.
