KNOW ALL MEN BY THESE PRESENTS, Dated January 10, 1971
WHEREAS the undersigned, Guy A. Poore,

hereinafter called Borrower, are (is) justly indebted to the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, hereinafter called the Government, as evidenced by one or more certain promissory note(s) or assumption agreement(s), hereinafter called note(s), executed by Borrower and payable to the Government, containing covenants and agreements of Borrower in addition to the promise(s) to pay money, and authorizing optional acceleration of the entire indebtedness upon Borrower's breach of any covenant or agreement, said note(s) being described as follows:

ALSO: all that piece, parcel or strip of land, triangular in shape and consisting of 0.5 acres, situate, lying and being at Slater in the county of Greenville, State of South Carolina, and indicated as Parcel C on a plat entitled "Map showing property owned by Slater Manufacturing Co., Slater, S. C.", made by Pickell & Pickell, engineers, April 4, 1951, revised May 5, 1952, and having according to said plat the following rates and bounds:

BEGINNING at an iron pin on the northeastern side of Gates Bridge road (the apex of said triangular strip) and running thence along line of property now or formerly belonging to J. P. Stevens & Co., Jr. 39-40 S. 226¹/₂ feet to an iron pin; thence S. 29-20 E. 20 feet to an iron pin; thence along the line of property conveyed to Albert C. Phelps by J. P. Stevens & Co., Inc., by its deed April 30, 1952, and recorded in the R.C. office for Greenville County, S. 40-16 W. 2277.5 feet to an iron pin, the point of beginning.

The above described triangular strip is the same property conveyed to Albert C. Phelps by J. P. Stevens & Co., by its deed dated May 31, 1952, and recorded in the R.C. office for Greenville County, S. C., in Deeds Volume 459, at page 141, and lies adjacent to the 136 acre tract hereinabove described.
