WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Waddell Road, near the City of Greenville, being shown as Lot No. 42 on a Plat of Wade Hampton Gardens, recorded in the RMC Office for Greenville County in Plat Book MM, Page 199, and being more particularly described as follows:
