WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Seven Thousand and no/100-----DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, on the southern side of Scuffletown Road and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Scuffletown Road at the corner of property owned by Atkins and running thence along the line of Atkins property S. 24 E., 269.6 feet to an iron pin; thence continuing with Atkins line S. 64-07 W., 120 feet to an iron pin; thence N. 24-0 W., 269.6 feet, more or less, to an iron pin on the south side of Scuffletown Road; thence along the south side of said Road N. 64-07 E., 120 feet to the point of beginning.
