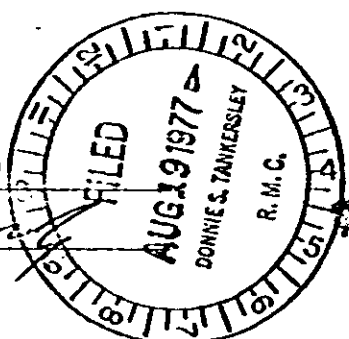
Harold Bagwell d/b/a Asphalt Paving Co. *Cancelled Donnie S. Tankersley R.M.C.*
