C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty Thousand Two Hundred and No/100

DOLLARS (\$ 40,200.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Greenville County, South Carolina, and being known and designated as Lot 80 of Pine Brook Forest Subdivision, Section 1, as shown on a plat thereof prepared by Robert R. Spearman and Charles K. Dunn, Surveyors, dated March 15, 1972, recorded in the RMC Office for Greenville County in Plat Book 4X at page 48, and having, according to said plat, the following metes and bounds, to-wit:
