TO ALL WHOM THESE PRESENTS MAY CONCERN: WILLIAM L. BROWN and ETHEL M.

BROWN

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand Two Hundred and No/100 DOLLARS (\$ 10,200.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Seventy-Three and No/100 Dollars (\$73.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Lady Marion Lane, near the City of Greenville, being shown as Lot No. 169 on a revised Plat of Sherwood Forest, recorded in Plat Book "GG" at Pages 70-71 and described as follows:

BEGINNING at a stake on the Southern side of Lady Marian Lane, at corner of Lot 134 and running thence with the line of said lot, S. 22-22 E. 150 feet to a stake; thence S. 81-32 E. 81.2 feet to a stake at corner of Lot 168; thence with the line of said lot, N. 2-29 E. 173 feet to a stake on Lady Marian Lane; thence with the Southern side of said lane, S. 85-46 W. 47.2 feet to a stake; thence continuing with said lane, S. 79-19 W. 99.9 feet to the Beginning corner.
