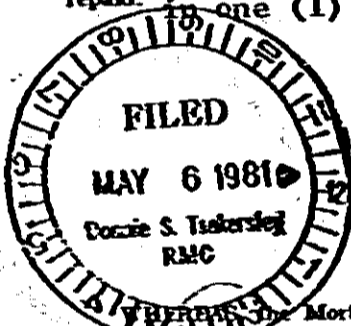

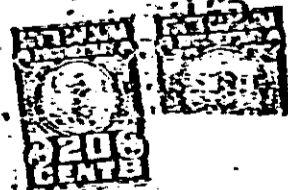

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Buncombe Street and the northern side of Alexander Street near the City of Greenville, being shown on Greenville County Block Book Sheet 150, Block 2, as Lot A, and being a part of the U. A. Briggs' property, having the following metes and bounds, to-wit:

BEGINNING at a point at the northwestern corner of the intersection of Buncombe Street and Alexander Street on the western right-of-way of Buncombe Street running thence with Alexander Street approximately S 55-20 W 129 feet to a railroad spike; thence N 19-55 W 66.6 feet to a point; thence approximately N 81-26 E 115.2 feet to a point on Buncombe Street; thence S 40-12 E 3.9 feet to the beginning point.
