THIS MORTGAGE was made this 28th day of April 1982 between the Mortgagor, LARRY L. STRINGER and KATHY W. 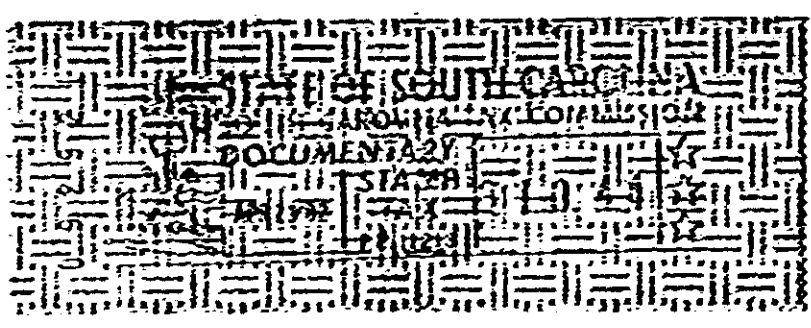
