Thirteen Thousand Five Hundred and No/100 Dollars (\$ 13,500.00)

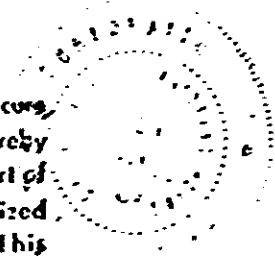
