of Thirty Dollars (\$30.00) to me in hand paid by the
City of Greenville, at and before the sealing of these presents
(the receipt whereof is hereby acknowledged), have granted,
bargained, sold and released, and by these presents, do
grant, bargain, sell and release unto the City of Greenville
its successors and assigns, a right-of-way in, over, and
through that certain piece, parcel or lot of land, situated
on or near Greene Avenue, in the City and County of
Greenville and the State of South Carolina, and more
particularly described as follows, to wit:
Beginning at man-hole at the intersection of Greene
Avenue and Jenkins Street and running South 75 degrees 10
Minutes East 194 feet to man-hole. Thence, 29 degrees 30 minutes
~~XXXXXXXX~~ East for a distance 167 feet to the property line
of A. M. Scarborough, said right-of-way to be eight feet wide.
For the purpose of establishing constructing or maintaining
a sewerage line over and through the said premises, for the
City of Greenville. The said A. C. Davis to have the right
to use the surface of the right-of-way. The City will replace
any fences of buildings it has been necessary to remove
during the maintenance of the said sewer line.
