**RIGHT OF WAY**

FOR AND IN CONSIDERATION of the sum of \$1,800.00 (\$ .75 ft.) to the undersigned in hand paid by the City of Greenville, S. C., the receipt whereof being hereby acknowledged, (I) ~~(we)~~ hereby grant unto said City of Greenville, a right-of-way or easement along, over or under (my) ~~(our)~~ property for the purpose of:

Installing a sanitary sewer line. Easement to begin forty feet  $\pm$  from corner of property of Rosa F. Douglas Greater Greenville Sewer District and along Duke Power right-of-way. Easement to run in an easterly direction along lake listed a J. M. F. Incorporated, and along with and at times crossing the Duke Power right-of-way on said property. Easement to be approximately 2,400 feet on said property with approximately eleven manholes; also, along lake owned by Isbell Lane Sisk with half interest to Sallie Clark Huguenin or T. F. Huguenin.

All pasture fences to be removed and replaced to the property owner's specifications. Any other conditions of this easement to be approved by the City of Greenville.

Purpose of this easement being to install 10" V. C. sanitary sewer line for John L. Mann Junior-Senior High School and Parkins Lake Development. Plans for said sewer are on file in the City of Greenville Engineering Department of the Public Works Department in City Hall.

Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.

Said property is described as follows:

On East Parkins Mill Road.

It is further understood and agreed that any exposed pipe will be covered; that all right-of-way will be smoothed and grassed; that all timber, limbs and tree tops will be hauled away.

TO HAVE AND TO HOLD all and singular the right to the City of Greenville, S. C., its successors and assigns. And (we) (I) do hereby bind (ourselves) (myself), (our) (my) heirs, successors or administrators or assigns, to warrant and forever defend all and singular said premises unto the Grantee herein.
