five and three-fourths per centum (5-3/4%) per annum until paid, said principal and interest being payable
at the office of Cameron-Brown Company
in RALEIGH, NORTH CAROLINA , or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Seventy-Eight and
40/100----- Dollars (\$ 78.40), commencing on the first day of
August , 1966 , and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of July , 1996 .

in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagor, its successors and assigns, the following-described
property situated in the county of Greenville

ALL that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, situate, lying and being near the City of Greenville, County of
Greenville, State of South Carolina, and being known and designated as Lot 14
on plat of Section I and II of Western Hills, which plat is recorded in the RMC
Office for Greenville County, South Carolina, in Plat Book QQ at pages 98 and
99, in that the according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Watkins Road, joint front corner of Lots 1 and 14; and running thence along the line of Lot No. 1, S. 60° 47' W. 150 feet to an iron pin; thence along the line of Lot No. 2, N. 29° 13' W. 90 feet to an iron pin, joint rear corner of Lots 13 and 14; thence N. 60° 47' E. 150 feet to an iron pin on Watkins Road, joint front corner of Lots 13 and 14; thence along Watkins Road, S. 29° 13' E. 90 feet to an iron pin, the point of beginning.
