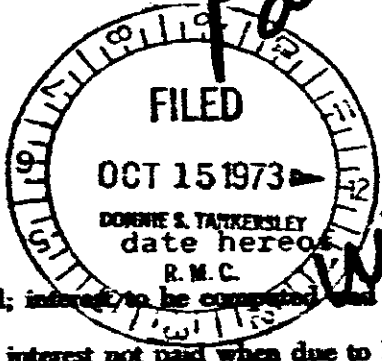
(herein called mortgagor) SENDS FORTH:
