"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot 171 on Second Revision of Traxler Park, recorded in Plat Book F at Pages 114-115 in the R. M. C. Office for Greenville County, and according to said plat described as follows:

"BEGINNING at an iron pin on the southern side of Mount Vista Avenue, joint front corner of Lots 172 and 171, and running thence with line of Lot 172, S. 25-23 E. 209 feet to iron pin; thence S. 77-27 W. 38.2 feet to iron pin; thence along line of Lots 166, 165 and 164, N. 59-53 W. 243.2 feet to iron pin on Mount Vista Avenue; thence with said Avenue N. 64-37 E. 175 feet to the point of beginning."
