MORTGAGE OF REAL ESTATE

WHEREAS, Dean L. Gosnell and Edna Gosnell

(hereinafter referred to as Mortgagor) is well and truly indebted unto Bankers Trust of South Carolina, N. A.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township about 6-1/2 miles south of the City of Greenville, on the north side of East Gantt Street and designated as Lot 17 on a plat of the property of Albert Taylor made by Dalton and Neves, May, 1946, recorded in the RMC Office for Greenville County in Plat Book P, page 49, and having according to said plat the following metes and bounds:
