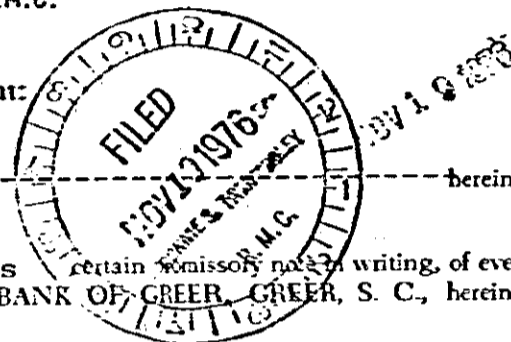

ALL that piece, parcel and lot of land, situate, lying and being in Greenville County, State of South Carolina, in the Sandy Flat Community, O'Neal Township, and being on the northern side of South Carolina Highway # 290 and shown on a plat of property prepared by Terry T. Dill, Registered Surveyor, dated June 18, 1973, and having the following metes and bounds as shown on said plat, to wit:

BEGINNING at the northwestern corner, joint front corner with right of way of South Carolina # 290, and runs thence N. 43-44 E. 210 feet to an iron pin, other property of grantor; thence S. 46-16 E. 208.7 feet to iron pin; thence along line of other property of grantor, S. 43-44 W. 210 feet to iron pin on right of way of South Carolina #290; thence with the right of way of said highway N. 46-16 W. 208.7 feet to the point of beginning.
