WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-Seven Thousand Nine Hundred and No/100 DOLLARS

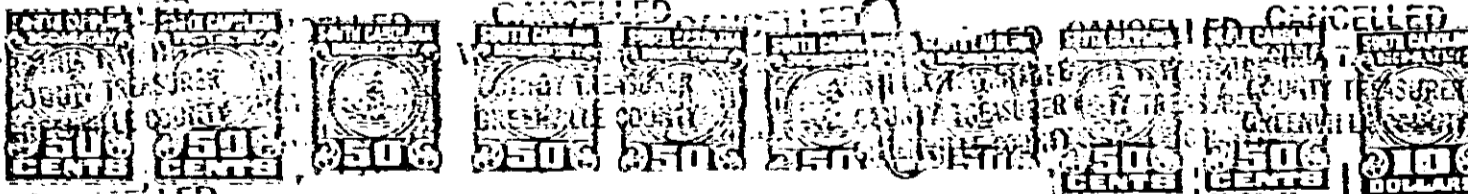
(\$47,900.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-nine (29) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$300) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the easterly side of Sugarberry Drive, being shown and designated as Lot No. 13, on plat of Dove Tree Subdivision made by Piedmont Engineers and Architects, dated September 18, 1972 and revised March 29, 1973, and recorded in the RMC Office for Greenville County, S. C., in Plat Book "4 X", at Pages 21, 22, and 23, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the easterly side of Sugarberry Drive, joint front corner of Lots Nos. 12 and 13, and running thence with the line of said lots, S. 76-05 E. 160.0 feet to an iron pin, joint rear corner of said lots; thence with the rear line of Lot No. 13, N. 13-55 W. 165.3 feet to an iron pin, joint rear corner of Lots Nos. 13 and 15; thence with line of said lots, N. 78-02 W. 149.7 feet to an iron pin on the easterly side of Sugarberry Drive, joint front corner of said lots; thence with the easterly side of Sugarberry Drive, S. 20-34 W. 88.5 feet and S. 13-55 W. 73.0 feet to an iron pin, the point of BEGINNING.
