All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, state of South Carolina, being a portion of Lots Nos. 5 and 3 on plat of property of Annie M. Moore, et al, recorded in the RMC Office for Greenville County in plat book C at pages 178 and 179, and having according to a recent survey made by R. K. Campbell recorded in plat book M-M at page 53, the following metes and bounds, courses and distances, to-wit:
