(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty Four Thousand and no/100 ----- Dollars (\$ 24,000.00) due and payable on or before August 20, 1976, or upon the sale of mortgagors present house, whichever occurs first

with interest thereon from date at the rate of 8 per centum per annum, to be paid: after maturity

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that piece, parcel or tract of land situate, lying and being in Chick Springs Township, County of Greenville, State of South Carolina, on the western side of Highway 253 (formerly Sandy Flat Road), and being a portion of Tract #2 as shown on Plat of property of S. L. Jones Estate recorded in the RMC Office for Greenville County, S.C. in Plat Book "G", at Page 233, and containing approximately 9 acres, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at a point in the center of the intersection of Highway 253 and the road leading to the dwelling house on the within described property and running thence along said private road N. 34 W. approximately 6.0 chains to an angle in said road; thence continuing along the center of said Road N. 44 1/2 W. 6.50 chains to an iron pin in said road; thence S. 64 3/4 W., 3.08 chains to a persimmon at Mountain Creek; thence along Mountain Creek as the line in a southeasterly direction to a point in the center of Highway 253; thence along the center of Highway 253 N. 03-11 W. to the point of beginning.

This is the same property conveyed to mortgagors herein by deed of Mittie Wherry Kidd dated August 3, 1976.

This is a second mortgage, and is junior in lien to a mortgage given this date to Fidelity Federal Savings and Loan Association in the amount of \$40,000.00.
