WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

DOLLARS (\$ 38,000.00) with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, lying on the southern side of Carol Drive, being shown and designated as Lot No. 3, on a plat entitled "Haselwood, Sec. I," dated June, 1973, prepared by Dalton and Neves Co., Engineers, and recorded in the RMC Office for Greenville County, S. C. in Plat Book 4X at Page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Carol Drive, joint front corner of Lots 2 and 3; running thence with the joint line of said lots, S. 43-51 W., 306 feet to an iron pin; running thence S. 45-05 E., 100 feet to an iron pin; thence S. 65-05 E., 70 feet to an iron pin at the joint rear corner of Lots 3 and 4; running thence with the joint line of said lots, N. 35-51 E., 301 feet to an iron pin on the south side of Carol Drive; thence with the south side of Carol Drive, N. 52-05 W., 125 feet to an iron pin, point and place of beginning.
