All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots 57 and 58, as shown on plat of Fresh Meadow Farms, recorded in Plat Book M at Page 127, and being more particularly described according to said plat as follows:
