(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eleven Thousand and No/100 (\$ 11,000.00) with interest thereon at the rate of Six per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Friartuck Road in the City of Greenville being shown as all of Lot 51 and a small portion of Lot 50 on Plat of Sherwood Forest recorded in Plat Book GG at Pages 70 and 71, and being more particularly described as follows:

BEGINNING at an iron pin on the northwestern side of Friartuck Road at the joint front corner of Lots 50 and 51 and running thence with line of Lot 50 N. 48-56 W. 131.9 feet to pin; thence N. 52-23 W. 35.7 feet to pin in rear line of Lot 50; thence along the line of Lots 50 and 51 N. 32-42 E. 78.7 feet to iron pin at corner of Lot 52; thence with the line of Lot 52 S. 48-56 E. 177 feet to pin on Friartuck Road; thence with the northwestern side of Friartuck Road S. 41-04 W. 75 feet to the point of beginning.
