WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of Air Base Road and Bonito Drive near the City of Greenville, being shown as Lot 33 on plat of Section 4 of Greenfields recorded in Plat Book II at page 57, and having according to said plat the following metes and bounds:

beginning at a stake at the southwestern corner of Bonito Drive and Air Base Road and running thence with the western side of Air Base Road, S 0-56 E 105 feet to a stake at the corner of Lot 34; thence with line of said lot, N 88-19 W 94.6 feet to a stake at corner of Lot 32; thence with line of said lot, N 21-32 W 82.7 feet to stake on Bonito Drive; thence with the southern side of said Drive, N 68-28 E 112.3 feet to a stake; thence with the curve of the intersection of Air Base Road, the chord of which is S 56-09 E 22.8 feet to the beginning.
