TO ALL WHOM THESE PRESENTS MAY CONCERN: Robert R. Galegar and Alice L. Galegar

(Hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-seven Thousand Six Hundred Ninety-seven and 15/100

(\$ 37,697.15-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, in the County of Greenville, on Bridgewater Drive, being shown and designated as Lot No. 319 of Section VII, Botany Woods Subdivision as shown on a plat recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book YY at Pages 76 and 77, and according to said plat, has the following metes and bounds-to-wit:

BEGINNING at an iron pin on the southeastern side of Bridgewater Drive at the joint front corners of Lots No. 319 and 320, Section VII and running thence with the curve of the southeastern side of Bridgewater Drive, the chords of which are S. 69-35 W., 69.7 feet to an iron pin; and S. 42-30 W., 90.3 feet to an iron pin at the corner of Lot No. 61 of Section II; thence with the line of said Lot S. 49-05 E., 182.4 feet to an iron pin; thence N. 66-27 E., 90 feet to an iron pin at the corner of Lot No. 320, thence with the line of Lot No. 320, N. 28-19 W., 198.1 feet to an iron pin; point of beginning.
