(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of EIGHTEEN THOUSAND NINE HUNDRED AND NO/100THS- (\$ 18,900.00 ), with interest thereon at the rate of 6-3/4 per cent per annum evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty five years after the date hereof unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Selwyn Drive near the City of Greenville, being shown and designated as Lot No. 24 on plat of Timberlake, Property of Robinson & Gaffney, made by Dalton & Neves in July 1955, recorded in the REC Office for Greenville County in Plat Book BB at page 185 and having according to said plat the following metes and bounds:

Beginning at an iron pin on the eastern side of Selwyn Drive and running thence along the line of Lot No. 25, N 84-16 E. 204.7 feet to an iron pin on the rear line of Lot No. 44; thence along the rear line of Lots Nos. 44 and 45, S 2-03 W 90.85 feet to an iron pin; thence along the line of Lot No. 23, S 84-16 W 192.4 feet to an iron pin on the eastern side of Selwyn Drive; thence along the eastern side of said Drive, N 5-44 W 90 feet to the point of beginning.
