All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of Broadford Road, being shown and designated as Lot No. 158, on plot of Del Norte Estates, on plot recorded in the RMC Office for Greenville County, S. C., in Plot Book "VVVW", at Pages 32 and 33, and having, according to said plot, the following metes and bounds, to wit:
