All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, and fronting on Highway 25 (Buncombe Road) and being a portion of the property shown on a plat recorded in Plat Book H at Page 59 in the RMC Office for Greenville County and beginning at an iron pin on Highway 25 and running N 36-3/4 W 290 feet; thence along a line roughly parallel to Buncombe Road N 53-3/4 E 120 feet to an iron pin; thence S 36-3/4 E 290 feet on the Buncombe Road; thence along said Road S 53-3/4 W 120 feet to the beginning point.
