WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-two Thousand Four Hundred Sixty-eight and 92/100-----DOLLARS

(\$ 22,468.92-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-eight years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$300) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 302 on plat of Section 6, Colonial Hills, as recorded on plat recorded in the RMC Office for Greenville County in Plat Book WWW at page 13 and having the following courses and distances:

BEGINNING at an iron pin on the eastern side of Woodleigh Drive at the joint front corner of Lots 302 and 303 and running thence along the joint line of said lots, N. 59-05 E. 171.9 feet to an iron pin; thence along the rear line of Lot 302, S. 30-57 E. 90 feet to an iron pin at the rear corner of Lots 301 and 302; thence along the joint line of said lots, S. 59-05 W. 160.93 feet to an iron pin on Woodleigh Drive; thence along said drive, N. 37-36 W. 90 feet to the point of beginning.
