WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the eastern side of Ridgewood Drive, being shown and designated as Lot No. 7 on plat of Woodland Hills, recorded in Plat Book Y, at Page 60, and described as follows:

BEGINNING at an iron pin on the eastern side of Ridgewood Drive at the joint front corner of Lots Nos. 8 and 7, and running thence with the line of Lot 8 N. 73 E. 160 feet to an iron pin; thence S. 17 E. 43.3 feet to an iron pin; thence S. 43 W. 184.7 feet to iron pin in Ridgewood Drive; thence with the eastern side of Ridgewood Drive N. 17 W. 135.1 feet to the point of beginning.
