All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Parliament Road being shown as lot 28 on plat of Merrifield Park Section II recorded in Plat Book WW at pages 50 and 51 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
