WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the eastern side of Faris Circle in the City of Greenville, being shown as lot 97 on a plat of Forest Heights Subdivision recorded in Plat Book P at page 71 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Faris Circle at the joint front corner of lot 97 and lot 98 and running thence with lot 98 N. 77-33 E. 225 feet to an iron pin at the joint rear corner of lot 97 and lot 98; thence S. 26-55 E. 215.2 feet to an iron pin at the joint rear corner of lot 93 and lot 97; thence with lot 93 N. 86-19 W. 340 feet to an iron pin on the eastern side of Faris Circle; thence with said Circle N. 4-24 E. 50 feet to an iron pin; thence still with said Circle N. 5-21 W. 75 feet to the point of beginning.
