TO ALL WHOM THESE PRESENTS MAY CONCERN: James M. Cadieu

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) in the sum of Twenty Thousand and No/100 DOLLARS (\$20,000.00), with interest thereon at the rate of Seven per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the west side of Butler Springs Road, being shown and designated as Lot 130 on a plat of Heritage Hill, made by Piedmont Engineers & Architects, May 26, 1964, recorded in the RMC Office for Greenville County in Plat Book "YY", at Page 187, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the western side of Butler Springs Road at the joint front corner of Lots 130 and 131 and running thence along the line of Lot 131 N. 76-43 W. 146.9 feet to a point in the line of Lot 132, joint rear corner of Lots 130 and 131; thence along the line of Lot 132 N. 2-19 E. 77.4 feet to a point, joint rear corner of Lots 130 and 128; thence along the line of Lot 128 N. 86-27 E. 71.1 feet to a point, joint corner of Lots 128 and 129; thence along the line of Lot 129 N. 86-27 E. 98.7 feet to a point on the western side of Butler Springs Road; thence along Butler Springs Road S. 13-30 W. 125 feet to the point of beginning.
