All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwesterly side of Lion's Club Road, being shown and designated as Lot No. 2 on plot of Property of H. O. Huff, recorded in the RMC Office for Greenville County, S. C., in Plot Book "TT", at Page 170, and having, according to said plot, the following metes and bounds, to-wit:
