

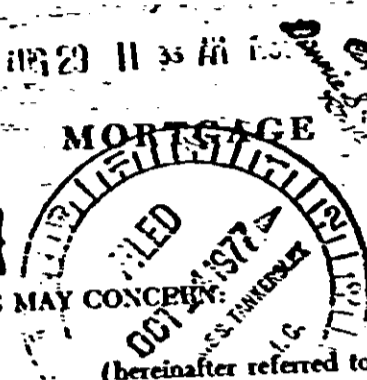

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Seven hundred and No/100- - - - - DOLLARS (\$ 4700.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the West side of Afton Avenue, and known and designated as lot No. 49, according to plat of Alta Vista, said plat being recorded in the R.S.C. Office for Greenville County in Plat Book G at Page 20, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the West side of Afton Avenue, 290 feet from the Southwest intersection of McIver Street and Afton Avenue, at joint corner of lots Nos. 48 and 49, and running thence along line of lot No. 48, N. 85-40 W. 160 feet to iron pin, rear joint corner of lots Nos. 48 and 49; thence S. 4-15 W. 60 feet to iron pin, corner of lot No. 50; thence with line of lot No. 50, S. 85-40 E. 160 feet to iron pin on Afton Avenue; thence along the Western side of Afton Avenue, 4-15 E. 60 feet to the beginning corner."
