All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the Town of Mauldin in Austin Township, Greenville County, State of South Carolina, being known and designated as Lot No. 68 as shown on a plat prepared by R. K. Campbell, R. L. S., dated March 29, 1960, entitled "Windsor Park," recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book RR at page 25, and having according to said plat the following metes and bounds:
