All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 105 on plat of Gray Fox Run Subdivision prepared by C. O. Riddle dated November 6, 1975 and revised March 4, 1976 and recorded in the R.M.C. Office for Greenville County in Plat Book 5-P at Page 16, and having according to said plat, the following metes and bounds, to-wit:
