BENJAMIN FURMAN WATKINS, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being shown and designated as Lot No. 4 on plat of the property of Mrs. Joe L. Watkins, recording in Plat Book FF at page 425, and having the following metes and bounds, to wit:
