WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Holmes Drive, in the City of Greenville, known and designated as lot # 87, on a plat of the property of Central Development Corporation, prepared by Dalton & Neves in October 1951, and recorded in Flat Book BB at Pages 22 and 23, and described as follows:

"BEGINNING at an iron pin on the Western side of Holmes Drive, at the front corner of lots 86 and 87, and running thence N. 61-22 W. 159 feet to an iron pin in line of lot # 85; thence with line of said lot, S. 11-45 W. 92.4 feet to an iron pin at rear corner of lot # 88; thence with the line of said lot, S. 66-53 E. 136 feet to an iron pin on the Western side of Holmes Drive; thence with the Western side of said Drive, N. 26-28 E. 75 feet to the point of beginning."
